

2024 Fair's Fantasy Lights Craft Show

DATE: Dec. 13th 2024, 6:00pm-9:00pm | Dec. 14th 2024, 6:00pm-9:00pm (Vendor Shopping from 5:00-6:00pm) | Dec. 15th 2024, 6:00pm-8:00pm

SET UP: Thursday, Dec 12, 2024 from 4:00pm-7:00pm or Friday, Dec 13, 2024 from 3:00pm-5:00pm ALL VENDORS MUST BE SET UP AND CARS MOVED TO DESIGNATED PARKING AN HOUR BEFORE CRAFT SHOW BEGINS

EVENT: This is the second craft show taking place in conjunction with the well-attended Fair Fantasy Lights Drive-Thru. Santa Claus will also stop by to take pictures in the Merchant Bldg during the craft show. All products must be homemade/handmade. No MLM products will be admitted. Any crafter who packs up before the end of the show will not be admitted in the future unless previously arranged. This year, the hours have been shortened to match the Fair Fantasy Lights Drive-Thru.

LOCATION: Merchant Bldg at the Lenawee County Fair & Event Grounds (LCF) |602 N. Dean St. Adrian, MI 49221

SPACE FEE: \$60 per space (10x10) for the entire weekend. Members are initially limited to 2 spaces to allow more crafters to participate in the show. If you are interested in a 3rd space, note your request on the application. **NO REFUNDS.**

PRODUCT VARIETY: Products will be limited with the number of crafters admitted. Only items listed on your application will be allowed. Once a certain percentage of the spaces available are taken by a certain product, no others will be admitted. A waiting list will be created and if there is a cancellation of a like product, crafters will be contacted on the waiting list. (Example: Only 15% of the vendors can have jewelry)

ELECTRICITY: Spaces with electricity are limited and are not guaranteed. Extension cords cannot cross aisles or walk ways.

PARKING: Parking will be available on the south side of the Merchant Bldg and will be marked. Please do not park in customer areas.

DISPLAY: Be creative! Please be sure your entire display, including chairs are contained within your allotted space. Tables are available for rent for \$5 each (Max of 2 tables per 1 space). All tables must have floor length coverings.

PAYMENTS: This year, the craft show will be juried in order to ensure a variety of quality crafts/products. Applications are due by November 1, 2024 and you will receive a confirmation email by November 4, 2024. All payments must be made by November 21, 2024 or your space may be forfeited.
